Nigeria Needs \$15 Billion USD Annually on Transport to Meet the 30yr Infrastructure Master Plan - Victor Udoma, Minister of Budget and National Planning



The Minister of Budget and National Planning has announced that Nigeria needs 15 Billion USD annually on transportation alone, to meet the 30yrs national integrated infrastructure master plan. He stated this during a National Summit on Establishment, Management and Operations of Truck Transit Parks in Nigeria, the program was organized by the Nigeria Shippers Council in collaboration with the Federal Ministry of Transportation in Abuja Nigeria.

The Minister was represented. The Truck Transit Parks would be state of the art, common user facilities sited off the highway along high freight corridors. These transit parks would have gas stations, mechanic workshops, clinics and hostel-style accommodation. Other features of the parks are twenty four (24) surveillance, modern truck management systems and telemetric to support the detection and assessment of available parking spaces.

According to a presenter, Dr Ikenna Nwosu of the Nigeria Economic Summit Group, ninety eight (98%) per cent of truck drivers currently select parking locations at their discretion thus creating avoidable traffic gridlock and endangering commuters. He went further to give some depressing statistics; three

hundred and six (306) persons were killed by petrol tankers in 2016, and 1,000 by container trucks in a similar time span.

The Truck Transit Parks are expected to alleviate the need for road side parking, thus reducing congestion and crash rates on the highways. Other benefits would be security of cargo, efficient means of monitoring freight, Improved efficiency of supply chain management and a leap in revenue for the government.

Various speakers called for the enactment of enabling legislations and policy framework to drive patronage and boost investor confidence in the scheme. TGI was active participant and looking forward to its fruition.

Nigeria's INNOSON Motors Commence Export of its IVM brand of Cars



Nigerian motor vehicle manufacturing company, Innoson Motors, is set to export made-in-Nigerian cars to Mali. The Charged Affair of Nigeria in Mali, Yara Abdulsalam, said this followed an MoU signed by INNOSON and a Malian firm to export 400 locally made vehicles to Mali. Abdulsalam made the announcement on Friday 21st July, 2017 in Abuja when he led a delegation of businessmen

from Mali to visit the Nigerian Minster of Foreign Affairs Geoffrey Onyeama.

He noted that the development was seguel to a "Made-in-Nigeria products

exhibition" held in Bamako in 2016. The exhibition was facilitated by Ginco Group, a Nigerian firm based in Mali to showcase Nigeria's potentials. By this, INNOSON has become the first Car Manufacturing Company in Nigeria to begin car export. This falls in line with the industrialization drive of the Government of Nigeria, and TGI commends this giant stride., it is good news for industrialization in Africa.

Innoson Motors, is set to export the IVM brand, made-in-Nigerian cars to Mali.

Abuja - Kaduna Rail line generates N1m daily- Minister

The Abuja to Kaduna rail line now generates one million Naira daily, Minister of Transportation Mr Rotimi Amaechi disclosed.

In an interview with the News Agency of Nigeria (NAN) on Tuesday in Benin, Amaechi said that the feat was because of the increase in passengers that patronise the rail. He attributed the passenger surge to the security challenges faced by commuters along the

route. "We are spending N56 million per month, we are getting back only N16 million. Now there is an improvement; we now make N30 million, (that is) one million Naira per day. "The improvement started last month because of increase in passengers because of the kidnapping on the road," he said.

The minister said that government was using the previously generated revenues on the maintenance of the coaches and

other logistics. Amaechi said that government would address the issue of touting at the Idu rail station with the expected arrival of IO more coaches by October. He, however, disclosed that the arrival of the new coaches would require more resources for maintenance in order to meet customers' expectations.

NAN recalls that the Abuja-Kaduna rail line commenced commercial operation in July 2016. NAN

Strengthening Local Content Policy in the Maritime Sector in Nigeria



The Nigerian Maritime Administration and Safety Agency (NIMASA) recently rolled out new policy guidelines aimed at strengthening the cabotage regime. This development apparently came as a result of outcry from stakeholders and citizens, especially the thousands of unemployed seafarers and cadets

The Coastal and Inland Shipping Act (Cabotage Act) No. 5 2003 was a piece of legislation enacted to restrict the use of foreign vessels and

aliens in coastal and inland shipping in Nigeria. It was inspired by the Jones Act in the United States of America, which prohibits the use of foreign vessels in inland and coastal shipping in that country. However, due to the peculiarities of the Nigerian situation, liberal waivers were introduced in the Act. These waivers, well intended as they were have been abused greatly, thus perpetuating the situation the Act was meant to address.

The Act stipulates that vessels for use in Inland and Coastal shipping must be: Built in Nigeria, Owned by Nigerians, Manned by Nigerians and Registered in Nigeria. Some measure of gains have been made

in thirteen (13) years of the Act, But stakeholders believe that it has fallen well short of expectations. The news of the new Cabotage Compliance Strategy has been well received as it is an acknowledgement from NIMASA that there is a lot of ground to cover.

According to the Director General,
Dr Dakuku Peterside, waivers shall
not be entertained for certain positions any longer". He noted that,
"The era of foreigners taking over
jobs that Nigerians are qualified for
in the maritime sector is over".
This is a foretaste of new direction
articulated in the Cabotage amendment Bill pending before the National assembly.
